Qualifying ribbons will be awarded to each dog/owner team who achieves a score of 170 or better. Placement rosettes will be awarded to the top 5 high scoring teams in the A classes in each Level. Placement ribbons will be awarded to the top 5 high scoring teams in the B classes in each level. Championship rosettes will be awarded to all teams completing a Championship title.
